MARIN HUMANE'S ANIMAL SERVICE OFFICERS ARE SCHEDULED FOR 24 HOURS A DAY, 365 DAYS A YEAR COVERAGE.

INCLUDED AMONG THESE ARE ANIMAL TRAINING CLASSES AND BEHAVIOR CONSULTATIONS IN THE BEHAVIOR & TRAINING DEPARTMENT, HUMANE LAW ENFORCEMENT TRAINING ACADEMIES, SEMINARS AND WORKSHOPS, CLASSROOM VISITS, SHELTER TOURS, STUDENT VOLUNTEER OPPORTUNITIES, SUMMER CAMP, AFTER SCHOOL CLUBS, AND ANIMAL ASSISTED THERAPY VISITATIONS. MARIN HUMANE ALSO PROVIDES FREE PET FOOD AND ASSISTANCE TO THE PETS OF HUNDREDS OF LOW INCOME GUARDIANS THROUGHOUT MARIN COUNTY AS PART OF AN EFFORT TO KEEP PETS IN THEIR HOMES AS LONG AS POSSIBLE.
